Our Spark Technology Innovation Marketplace is built upon a products and services filter system. The filters consist of 4 distinct categories:

1. **Subject Area (2 levels)**
2. **Delivery Method (2 levels)**
3. **Location**
4. **Security**

Subject Area

Level 1 allows customers to select a high level sector, such as transport or local government. Level 2 then allows you to select a more specific area, such as rail or citizen engagement.

Level 1 includes:

- local government
- police/justice
- fire and rescue
- education
- geospatial and environment

Delivery Method

Level 1 allows customers to select a high level delivery method, such as artificial intelligence or security.

Level 2 then allows you to select a more specific area, such as machine learning or body worn cameras.

- artificial intelligence and automation
- simulated and enhanced environments
- engineering and materials science
- data
- wearables
- transport
- security

Within the filters for the Subject Area and Delivery Method there is a second level of identification.
