What will it cover?

Public Sector Passenger Transport Solutions DPS including Regional & National Taxis and Coaches.

This new commercial agreement will be available as a Dynamic Purchasing System offering public sector organisations the choice of passenger transportation solutions to provide services including but not limited to school travel, business travel, vulnerable adults and children services, community transport, non-emergency hospital transportation and prisoner transportation.

What is a Dynamic Purchasing Solution?

A Dynamic Purchasing System (DPS) is an electronic procurement procedure used to develop contracts for goods and services commonly available on the market. Requirements are divided into filters for goods and services.

How do you register as a supplier on the DPS?

The DPS platform is available via the CCS Supplier Registration Service (SRS) <https://supplierregistration.cabinetoffice.gov.uk/>. To register, Suppliers will need to complete a selection questionnaire which is made up of DPS mandatory questions and category specific questions. Suppliers can register at any point during the lifetime of the commercial agreement but we recommend you register within the first 30 days following the OJEU going live, to maximise your chances of being considered for all possible spend opportunities.

How can you filter within the DPS?

Under the DPS there are no lots as such, however suppliers will be able to classify themselves by the following four distinct categories:

1. Vehicle type

1. **Top Level:** Taxi, minibuses, coaches
2. **Second Level:** Hackney, minicab, executive, minibus/coach size

2. Service type

1. **Top Level:** School travel services, business travel services, non emergency hospital transportation, vulnerable adult and children transportation, community transport, prisoner transportation

3. Geographic allocation

1. **Top Level:** UK: England, Ireland, Scotland, Wales
2. **Second Level:** Regions
3. **Third Level:** Boroughs

4. 24 hour service offering

1. **Top Level:** yes/no

Customers can then filter the elements to produce a shortlist of appointed suppliers to invite to a competition. A competition involves a customer's requirements being sent to the shortlist of appointed suppliers, who are then invited to submit a specific tender to fulfil these requirements. The tenders are then evaluated and a direct contract is then awarded to the winning supplier.
